## **DISCUSSIONS**

#### <u>Waxes</u>

J D Downing led a discussion about how to regulate waxes for the 2021-22 season. Some teams had leftover low-flouro waxes. Coaches don't have experience with new green products that are coming out. Consensus was to stay with the current steering committee approved wax list and have steering committee add new waxes as coaches have more experience with them.

## **COVID-19 Guidelines**

Consensus to extend OHA vaccination requirements to non-school-based program coaches and all volunteers who work at OISRA races. All volunteers will register with a separate registration button. (Parents will not register as volunteers through their child's registration button.) Coaches will encourage parents to register early as volunteers so the teams will have a good pool of vaccinated volunteers to draw on for race help.
