The Board of Directors met on September 20, 2022.

BOARD RESOLUTIONS AND ACTIONS

REPORTS AND DISCUSSIONS

- Sarah presented financial information about the transactions regarding the money in the OISRAN account. She clarified that some of the money that was transferred to OISRAN from the OISRA account, based on the percentage of Nordic skiers, is being used for the cost of setting up the new website. OISRA paid for the legal fees for setting up the OISRAN as a new 501 (C) 3 organization.
- 2. Jinny explained the **insurance coverage** for 2022-23: Liability Insurance, Cyber Insurance, Accident Insurance (with a \$100 deductible), Directors & Officers Insurance. All coverage is for a full year, starting and ending on September 15th.
- 3. Discussion about **Webscorer**: Mike Anderson (by email) recommended paying \$250 for one PRO subscription (which has 5 device licenses) plus paying \$50 for the subscription for 5 additional device licenses. This number of device licenses should take care of all the Webscorer needs for all leagues, using one account. Jinny will follow up with Mike to determine exactly how to distribute the device licenses.
- 4. Discussion about **state championship awards**: agreement to use team trophies for photos only and collect the team awards after the awards ceremony to be saved for use the next year.
